**MODIFICATION OF CONTRACTUAL AGREEMENT FOR THE PROVISION OF
ELECTRICAL SERVICES FOR THE CANTON WATER POLLUTION
CONTROL FACILITY AND ITS PUMP STATIONS**

THIS MODIFICATION OF AGREEMENT (Hereinafter referred to as "Modification") is made this 23RD day of June 2014, by and between the TOWN OF CANTON WPCA, a municipal corporation organized and existing under the laws of the State of Connecticut (hereinafter the "WPCA"), and J.H LAPIERRE, JR. AND SON, LLC ELECTRICAL CONTRACTOR, of 6 Arlington Road, Windsor Locks, Connecticut 06096 (hereinafter "Contractor"). The purpose of this Modification is to extend the Agreement dated March 2, 2009 (hereinafter referred to as "Agreement") with the changes specified below. All other term and conditions of the Agreement will remain the same.

WITNESSETH

WHEREAS, the WPCA has a contract for electrical services with Contractor;

WHEREAS, both the WPCA and Contractor desire to continue to contract under the same terms and condition of the AGREEMENT except as modified below; and

WHEREAS, the WPCA and the Contractor desire to extend the Agreement dated March 2, 2009 (a copy of which is attached hereto as Exhibit A) by the execution of this Modification;

THEREFORE, in consideration of the recitals set forth above and the mutual promises by the parties below, the parties agree to modify the Contract dated March 2, 2009 as follows:

1. General - The Contractor and WPCA agree to modify the fees as described in Exhibit B in the Agreement as follows:

<u>Classification</u>	<u>Regular Rate</u>	<u>Overtime Rate</u>
1. Journeyman Electrician	56.00 per hour	84.00 per hour
2. Apprentice Electrician	48.00 per hour	72.00 per hour
3. Utility Truck 2,000lb Crane with operator	89.00 per hour	133.50 per hour

2. Term - This Modification shall extend the term of the Agreement from the period of execution of this Modification to June 30, 2017.



All other terms of the Contract Dated March 2, 2009 shall remain the same.

This Modification may be executed in one or more counterparts, each of which shall be considered an original instrument, but all of which shall be considered one and the same Modification, and shall become binding when one or more counterparts have been signed by each of the parties hereto and delivered (including delivery by facsimile) to each of the parties.
