This FIRST MODIFICATION of Agreement for Professional Services No. 0907 (“First Modification”) dated as of January 13, 2013, is by and between the Town of Canton, a municipal Corporation having its territorial limits within the County of Hartford, acting herein by Richard Barlow, First Selectman, duly authorized, which has an address of 4 Market St, Collinsville, CT 06022 (hereinafter referred to as the “Town”), and TaxServ Capital Services DM-CT, LLC which has an address of 1313 Dolley Madison Blvd., Suite LL-130, McLean, VA 22101-3926, acting herein by Roger Blain, Senior Vice President, duly authorized (hereinafter referred to as the “Provider”, “Contractor” or “TaxServ”).

RECITALS

- R-1. Town is a Connecticut Municipal Corporation.
- R-2 Provider is a Virginia limited liability company experienced in providing municipal collection and related services for its clients (“Clients”).
- R-3. Town and Provider entered that particular Agreement for Professional Services No. 0907 dated as of January 13, 2010 (“Agreement”).
- R-4. Town and Provider desire to amend the Agreement as follows:

AGREEMENT

In consideration of the mutual promises contained herein, the payments to be made hereunder, for the good and sufficient services to be rendered hereunder, TEN AND NO/100 DOLLARS (\$10.00) and other good and valuable considerations, the receipt and sufficiency of which are hereby acknowledged, the parties, intending to be legally bound, agree as follows:


1. Agreement Amendment – The parties agree that the Agreement is amended as follows:
 - Agreement Term Extension – Pursuant to paragraph 2 of the Agreement, the term of the Agreement is hereby extended for one (1) year (through January 13, 2014), with two (2) one year Town options remaining (to January 2015 and January 2016). The overall term of the Agreement shall expire on January 13, 2016 (“Expiration Date”)
2. Agreement Ratification – Except as modified herein, the Agreement is reaffirmed and ratified.


